# **Purpose & Applicability**

This application form is for requesting minor amendments to parkway landscaping in accordance with Land Use Code Section 6.3.10(D). It ensures that any proposed changes comply with Fort Collins Streetscape standards, relevant zoning standards, and the Larimer County Urban Area Street Standards.

- The submittal deadline for Minor Amendments is Wednesday at 4:00PM MST each week
- Projects routed on Thursdays pending a complete submittal including correct materials and format
- Comments and markups will be sent on the Friday two-weeks after the routing day
- Once all departments approve the proposed changes, the Minor Amendment will be recorded electronically

# **Submittal Requirements – Electronic Only**

The initial parkway landscape [minor amendment] submittal shall consist of the following:

### □ Landscape Plan

- Include the dimensions of the parkway and the location of proposed plantings on the landscape plan
- Ensure there is 50% live plant group coverage
  - Trees do not count toward the calculation, refer to Vegetation website to determine the size of each planting at full maturity
- Call out the non-plant ground cover [wood mulch / rock cobble / breeze etc.]
  - If using rock cobble; rocks need to be 2" diameter or smaller
  - All mulched areas (wood or rock) require live plants
- Include the common and scientific names of the proposed plans
  - These names can be found in the <u>Vegetation Database</u>
- List the plant quantities

### □ Tree Protection

- Tree Protection Notes: linked <u>here</u> and found under Section D of the Standard Notes for Development Review.
- Include Tree Protection notes IF applicable to your project
  - Add the notes to the plans or include in the plan set as a separate document
- Be mindful of the critical root zone. Only HAND-DIG perennials close to the tree
- Wood mulch ring should be called out on the plans. Ensuring a minimum of 3' diameter and 2-4" deep

### Irrigation plan

- If no changes are being made to the existing irrigation, note this on the plans
  - Drip irrigation is recommended for trees, shrubs, and perennials

### All documents shall be emailed to MinorAmendments@fcgov.com

- □ All submitted documents are required to be in PDF format and named appropriately.
- □ Correct file naming is required as part of a complete submittal.
- ☐ Materials submitted in an incorrect format or with an incorrect naming convention could cause delays with the routing and review of the minor amendment.

File name should have the corresponding number, followed by the file type prefix, project information, and round number. For example: 2\_SITE PLAN\_Project Name\_MA\_RD1. A list of numbers and prefixes for each file type can be found at the link below

Some examples of commonly submitted files / file names are:
